How Does It Work?

The GlobalBlock program is designed to help support domain portfolio optimization by providing “one stop” protection of trademark terms - like company and celebrity names - across a large number of domain extensions.

GlobalBlock provides domain blocking across 841+ extensions, including leading ccTLDs such as .cn and .de, along with gTLDs, Web3 and blockchain domains, and adult-themed extensions.

With the addition of adult-themed extensions, previously available through a separate service, GlobalBlock now offers a more streamlined approach to protecting brands against impersonation and cybercrime in one easy-to-manage solution.

The program also features Priority AutoCatch which automatically "catches" expired third party domains that match strings protected by the block list in the protected extensions.

In addition, the advanced GlobalBlock+ service provides automatic blocking of Homoglyph variants to prevent their use in phishing attacks and other malicious online activities.



What are Homoglyph Variant Domains?

Homoglyph variant domains exploit symbols and characters that look similar to standard spelling and alpha-numeric characters. They exist as attempts to lure legitimate traffic to less-than-reputable destinations
